Failure to give a 30-day notice will result in last month's tuition being non-refundable. If a 30-day notice is given for withdrawal, please allow PSP treasurer 2-4 weeks to issue a refund by mail.

^{*}Monthly payments are due by the 1st of every month. Payments made after the 10th will be considered late and will automatically be assessed a \$25 late fee.
